Passengers injured as bus overturns in Amravati

Amravati: A few persons were injured when a private bus overturned near a nullah in Maharashtra's Amravati district on Friday, police said. The private bus from Hoshangabad in neighbouring Madhya Pradesh was ferrying over 40 passengers to Baitul via Morshi in Amravati, an official said. As it crossed Arjun Nagar, the bus turned turtle near a nullah along the road, he said. Majority of the passengers escaped unhurt, while a few sustained minor injuries and were taken to a local hospital, the official said. The police have taken the bus driver into custody and further probe was underway to ascertain the cause of the accident, he added.

State records 973 Covid-19 cases, 12 deaths

Mumbai: Maharashtra on Friday reported 973 new coronavirus cases including 62 Omicron infections, and 12 pandemic-related deaths, the state health department said. The state's coronavirus case-load rose to 78,63,623, and death toll reached 1,43,687. On Thursday, the state had recorded 1,182 new cases and 19 deaths. Of 62 new Omicron infections, 60 were from Pune city and two from the Pune rural area. So far, 4,629 Omicron infections have been reported in the state, of which 4,456 patients have recovered.

Paes committed various acts of domestic violence against Rhea: Court

Mumbai: A metropolitan magistrate court here has held in its order in a domestic violence case filed by model-actor Rhea Pillai against her former partner, tennis player Leander Paes, that he committed various acts of domestic violence against her. The court also directed Paes to pay monthly rent of ₹50,000, apart from monthly maintenance of ₹1 lakh to Pillai if the latter chooses to leave their shared residence. Metropolitan magistrate Komalising Rajput had passed the order earlier this month, which was made available on Wednesday. 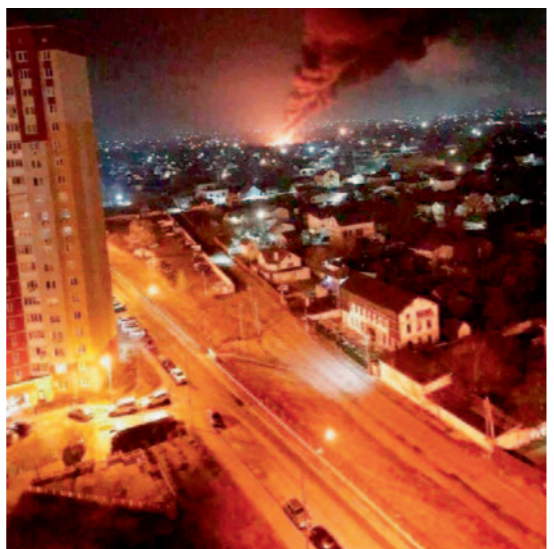

Staying in bunkers, MBBS students from Pune await evacuation from Ukraine

Pune, Feb 25: When Dnyanesh Ghadhve from Pune flew to Ukraine last year to pursue an MBBS course, he never imagined that he would be preparing to live in a bunker. Ghadhve, 19, is one of over 1,000 Indian students stuck in Zaporizhzhia in south-eastern Ukraine amid the Russian invasion. All students were taken into a bunker earlier in the day, he told PTI over phone. "Today we were taken into a bunker as part of a mock-drill. Now we are back in hostel," he said. He also heard reports that there was a blast on a nearby army base, Ghadhve added. Asked if they have received any instructions about how to leave the country, he said they were told that they will be taken to Romania by bus and from there they could be flown back to India. "ATMs in the city have run out of cash. People are buying essential supplies in bulk, so there are shortages at grocery stores too, he said. Maruti Dabhade, a Pune resident whose daughter Monika is pur-

suing MBBS in Odessa in southern Ukraine, said she and other students have already been moved to a bunker for safety. Hanumant Khaire, another Pune resident whose daughter Siddhi is a 4th-year MBBS student in Odessa, said she and others were safe for

Allegations against Malik appear to be well-founded, says PMLA court

Mumbai, Feb 25: Prima facie, there are reasonable grounds to believe that allegations against Maharashtra minister Nawab Malik are "well-founded", observed a special court here while remanding him in the custody of the ED in connection with a money laundering case.



The court, in its order, said it appears from the report that accused has not cooperated with the investigation on the crucial aspect. "Prima facie, there are reasonable grounds to believe that the accusations are well-founded under PMLA," the judge observed.

Special judge R N Rokade, designated to hear matters related to the Prevention of Money Laundering Act (PMLA), also said that sufficient time is required to be granted for the investigation of the offence and Malik's custodial interrogation was necessary. The court on Wednesday remanded Malik, a senior NCP leader, in the custody of the Enforcement Directorate till March 3. Its detailed order was

made available on Friday. Malik was arrested by the ED on Wednesday in a money laundering probe linked to the activities of fugitive gangster Dawood Ibrahim and his aides. The court, in its order, said it appears from the report that accused has not cooperated with the investigation on the crucial aspect. "Prima facie, there are reasonable grounds to believe that the accusations are well-founded

under PMLA," the judge observed. The court held that the probe was at a nascent stage and Malik's custodial interrogation is necessary to unearth all the ramifications involved in the crime. "The proceeds of crime have traversed since last 20 years and more. Therefore, sufficient time is required to be granted for the investigation of the offence," the judge said.

Nawab Malik hospitalised for stomach pain

Mumbai, Feb 25: Maharashtra minister Nawab Malik, arrested by the Enforcement Directorate two days ago, was admitted to the state-run J J Hospital here on Friday after he complained of stomach pain, an official said. A court has remanded the senior NCP leader in the ED custody till March 3 following his arrest in an alleged money laundering case. On Friday morning, Malik complained of stomach ache and was taken to the hospital around 11.30 am, an official from the J J Hospital said.

A person Kapil Gajbhiye and his friends, who were going from Yavatmal to Ralegaon, helped them soon after the accident. Seeing the seriousness of the accident, they contacted the Dist Superintendent of Police. Immediately police and ambulance had reached the spot.

The man's seriously injured wife Namrata (also a teacher) is undergoing treatment at the hospital. The deceased have been identified as Sunil Dhurve (41), his children Ayush (8) and Piyush(6). The teacher along with his family was going to Yavatmal to book a car for themselves. The accident took place when the tanker was trying to save a two-wheeler rider who came in the middle of the road near Parwa village close to Yavatmal town on Friday at 2.45 p.m. The driver of diesel tanker (MH-41 AV-9997), coming from the opposite direction, lost control of the vehicle and

then collided with the car. The accident was so terrible that the front portion of the car was completely shattered. All of them are residents of Patanbori and were travelling to Yavatmal from Darwha by car (MH-29BC-1251). Sunil's body was pulled out by lifting the car with the help of crane. His two children and wife were rushed to the hospital, but doctors pronounced both the children as dead. One of the children's birthday was planned to be celebrated two days later.
